## RE: Meeker Pit - File No. M-1976-038, Amendment (AM-3) Amend Permit to 124.20 Ac

Dear Katie Conrado:

On October 10, 2023, you submitted adequacy responses to AM-2. Those changes included increasing the acreage of affected lands. Pursuant to Rule 1.1(6) and 1.8.1(3) those changes were considered significant and constituted a new filing. As such the Division has terminated Amendment Application AM-2. All information provided moving forward will be considered AM-3.

Your Amendment application for the Meeker Pit 112c Construction Materials Reclamation Permit, which is located in Rio Blanco County has been filed. All comment and review periods began on October 12, 2023, and a decision date has been set for January 10, 2024.

Pursuant to Rule 1.6.6 you must also publish and mail new notice of application. The newspaper publication of a notice (published once a week for four consecutive weeks) regarding the filing of your application and transmittal of a copy of the notice to all owners of record of surface and mineral rights, holders of any recorded easements, and all owners of record of lands that are within 200 feet of the boundary of the affected land is required within 10 days of submittal. You must submit proof of the notice and mailings, such as Certified Mail Return Receipt Requested, to the Division prior to the decision date.

Please be reminded that all operators must contact the Colorado Department of Public Health & Environment, Water Quality Control Division regarding storm water permits.
