MMM Partnership, LLP, [36366 County Road 79, Crook, CO](#) (970)467-7780 has filed an application to expand an existing 112 Reclamation Permit with the Colorado Mined Land Reclamation Board under provisions of the Colorado Mined Land Reclamation Act for the extraction of construction materials. The Proposed mine is known as the MMM Partnership Gravel Pit and is located in the S ½ of the NW ¼ of Section 34, T12N, R49W of the 6th P.M., Logan County, Colorado. The proposed date of commencement is as soon as a permit is issued from the Division of Reclamation, Mining, and Safety is granted and the proposed date of completion will be such time as the operation is no longer productive or the owner determines to cease operations. The proposed future use of the land beyond construction material extraction will be reclaimed as rangeland consistent with the surrounding area.
