OBSERVATIONS

This inspection was conducted as part of the Division of Reclamation, Mining and Safety's (Division) normal monitoring program. Jake Wilkinson, representing the Operator, was present during this inspection. Photographs are included with this report in order to illustrate some of the conditions observed.

The Sacramento Access Tunnel is located approximately five miles north of Ohio City and accessed from FR 879. The site is a 110(2) operation that includes a total of 5.55 permitted acres. The Division currently holds a financial warranty amount of \$7,600.00 for this site. The Division will review the reclamation costs in order to ensure the financial warranty reflects the actual current cost of fulfilling the requirements of the Reclamation Plan. The Operator will be notified under separate cover if the Division determines that the current financial warranty amount is insufficient.

Adequate mine identification signage was noted at the entrance to the site.

Mining has not commenced at the site yet. Roads to the portals have been constructed. The portals are secured with locked steel doors.

No problems or violations were noted during this inspection.
