## **OBSERVATIONS**

This inspection was conducted as part of the Division of Reclamation, Mining and Safety's (Division) normal monitoring program. Jake Wilkinson, representing the Operator, was present during this inspection. Photographs are included with this report in order to illustrate some of the conditions observed.

The site is located on private land within the Gold Links Mine complex (M-1987-143, M-2016-083, M-2016-084). 53 holes were authorized to be drilled by the NOI. The holes were to be backfilled after drilling. An inspection conducted on May 17, 2022 found that except for one hole, the drilled holes had been backfilled with no sign of subsidence. One hole had drill pipe stuck in it that had not yet been removed by the drill operator. This inspection confirmed that the drill pipe had been removed and the hole has been backfilled pursuant to the reclamation plan requirements.

No problems or violations were noted during this inspection. Reclamation is complete at the site.
