## **OBSERVATIONS**

This inspection was conducted as part of the Division of Reclamation, Mining and Safety's (Division) normal monitoring program. Jake Wilkinson, representing the Operator, was present during this inspection.

The site is located approximately four miles north of Ohio City. Work authorized by the NOI included up to 20 boreholes, with no more than 3 open at any given time, and up to 30 trenches. The operator drilled 9 of the holes. All of the drilled holes have been sealed and reclaimed.

No problems or violations were noted during this inspection.
