Thanks, Tim. I will update our system to reflect that date.

I looked again at my inspection report from July 2022 (attached), and I have some other comments. The corrective action for weeds includes a Technical Revision to add a detailed weed control and management plan to the permit, and the Division requests that this be done as soon as practical (hopefully well in advance of May 2024). This plan should be developed in consultation with the Delta County Weed Program or other local weed control experts. Also, please consider if management of tamarisk can be done this fall.
