OBSERVATIONS

This inspection was conducted by Brock Bowles of the Division of Reclamation, Mining and Safety (Division). Mason King (Operator) was present for the inspection. The V. F. Smith Pit is located about 4 miles west of Cope, Colorado. The site is an active 110c operation with 9.9 acres permitted and the post-mining land use is rangeland. At the time of the inspection, it was warm, sunny and the ground was dry.

The mine entrance sign was in place with the required information and the permit boundary markers were in place. No mining was taking place.

The highwall was approximately 8 feet high at the highest point and about 50 feet long. Most of the highwalls in the rest of the pit had been graded and were mostly covered in vegetation. No noxious weeds were seen in the permit area.

About 2 acres were disturbed as part of the active mining area. The pit is not used very often and most of the pit area has self-reclaimed. The area south of the active mining area is about 2 acres in size and is well vegetated with grasses and mature trees.

The reclamation cost estimate was calculated as part of this routine inspection. The 2023 cost estimate was based on 2 acres of disturbance. The updated cost estimate is \$7,996 for the current disturbed area. The Division currently holds a bond of \$7,849 which is adequate to cover the cost of reclamation activities. The difference between the cost estimate and the current bond is \$147 which is less than 2% of the bond held. The Division won't request a bond increase at this time.
