The Colorado Division of Reclamation, Mining and Safety (The Division), has reviewed the above referenced report. The reports were received by The Division on 27 October 2023. The reports cover the time frame of July 2023 through September 2023 (Q3), for discharge monitoring required by the discharge permit.

This report appears to comply with the applicable sections of Rule 4.05.13(2)(a)(iii).

Spoil Spring outfall 022A discharged during the quarter. The recorded total recoverable iron appeared outside the permitted limit. No discharge from the monitored outfalls 003A, and 024A was recorded during quarter three.

With the exception of the spoil spring, no exceedances of water quality standards where identified in the Discharge Monitoring Report submitted.

The Division has no further comments at this time.
