PUBLIC NOTICE

Martin Marietta Materials, Inc (applicant); 1627 Cole Boulevard, Suite 200, Lakewood, CO 80401 and 720-245-6400, has filed an application for a Regular (112) Construction Materials Reclamation Permit with the Colorado Mined Land Reclamation Board under provisions of the Colorado Land Reclamation Act for the Extraction of Construction Materials. The proposed mine is known as Thunderbird Sand and Gravel, and is located at or near Sections 31 & 32, Township 20 South, Range 63 West, 6th Principal Meridian.

The proposed date of commencement is upon approval of the permit and the proposed date of completion is December 2043. The proposed future use of the land is developed water resources (WR) and wildlife habitat (WL). Comments must be in writing and must be received by the Division of Reclamation, Mining and Safety by 4:00 p.m. on November 23, 2023. Written comments should be filed through the DRMS web site or by mail and must contain the name, mailing address and telephone number of the interested parties as required by Construction Materials Rule 1.7.1(2)(a).

Comments related to noise, truck traffic, hours of operation, visual impacts, effects on property values and other social or economic concerns are issues not subject to this Office's jurisdiction.
