Hey Joe

Thank you for this response. Everything is looking good except for the missing Park County agreement to address Items #10 and #13 and, unfortunately, there is now a new item that needs to be addressed regarding Exhibit G. In response to Item 9.c, you have provided a revised E-1 map showing the location of the American Mine Parcel which is owned by MineWater Finance LLC, Christian Anders, Erik Swanson, and Beth Swanson. As discussed on the phone, a portion of this parcel is located within the affected lands boundary so you will need to comply with Rule 6.3.7 regarding MineWater LLC's legal right to enter onto this parcel. Per rule, this can be in the form of either a lease or a signed/notarized statement by the landowners (please note, you have already provided the required documentation for MineWater LLC's legal right to enter with MineWater Finance LLC, so you will only need to obtain this for Anders and the Swansons).
