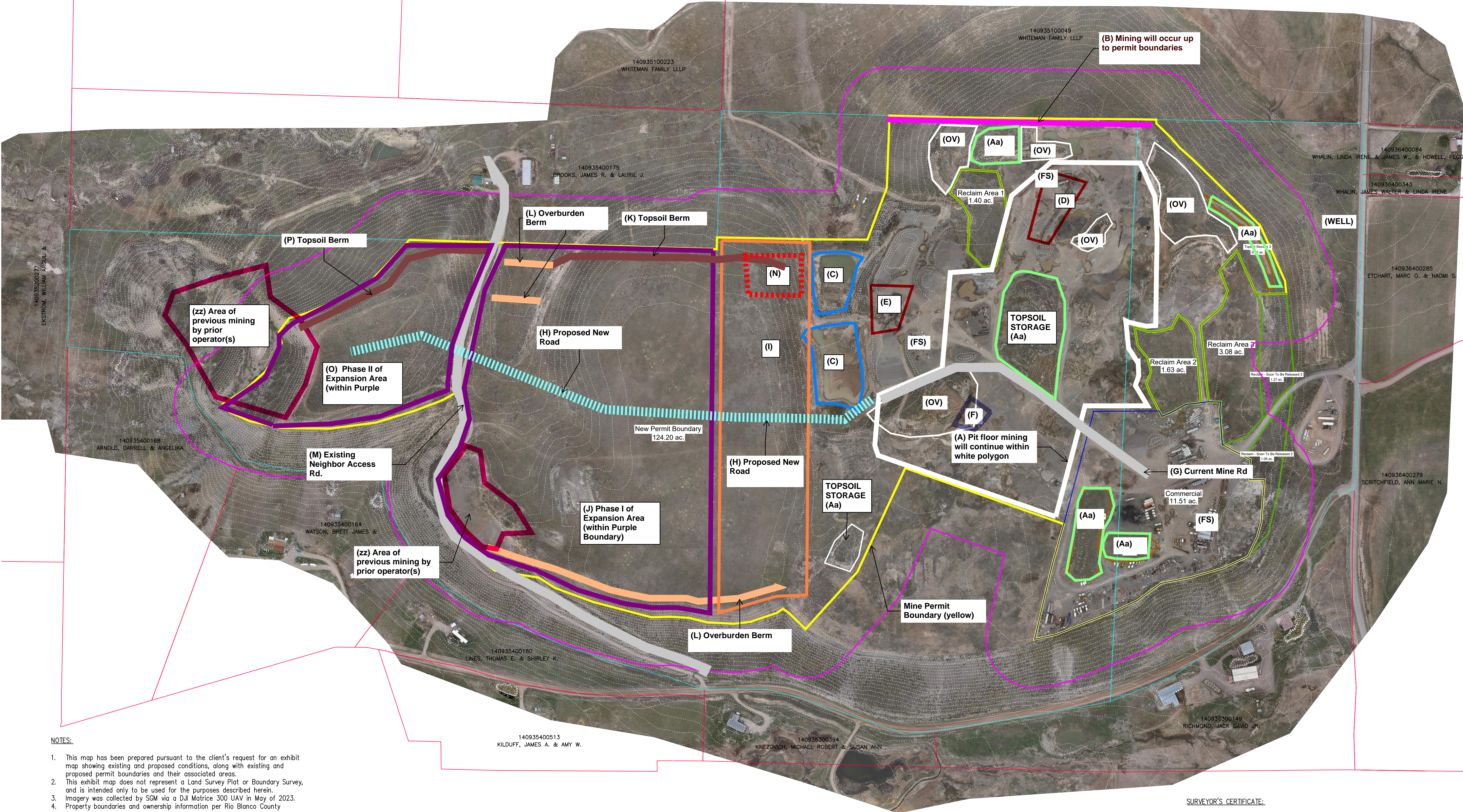

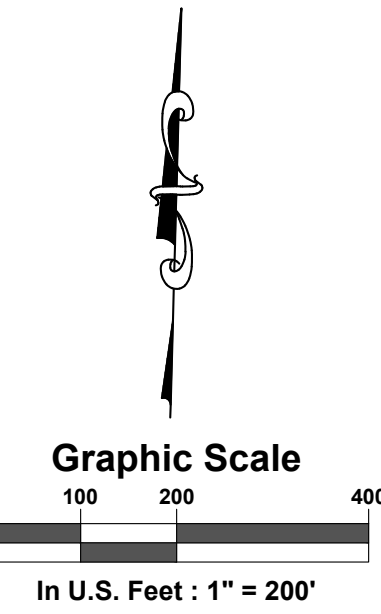

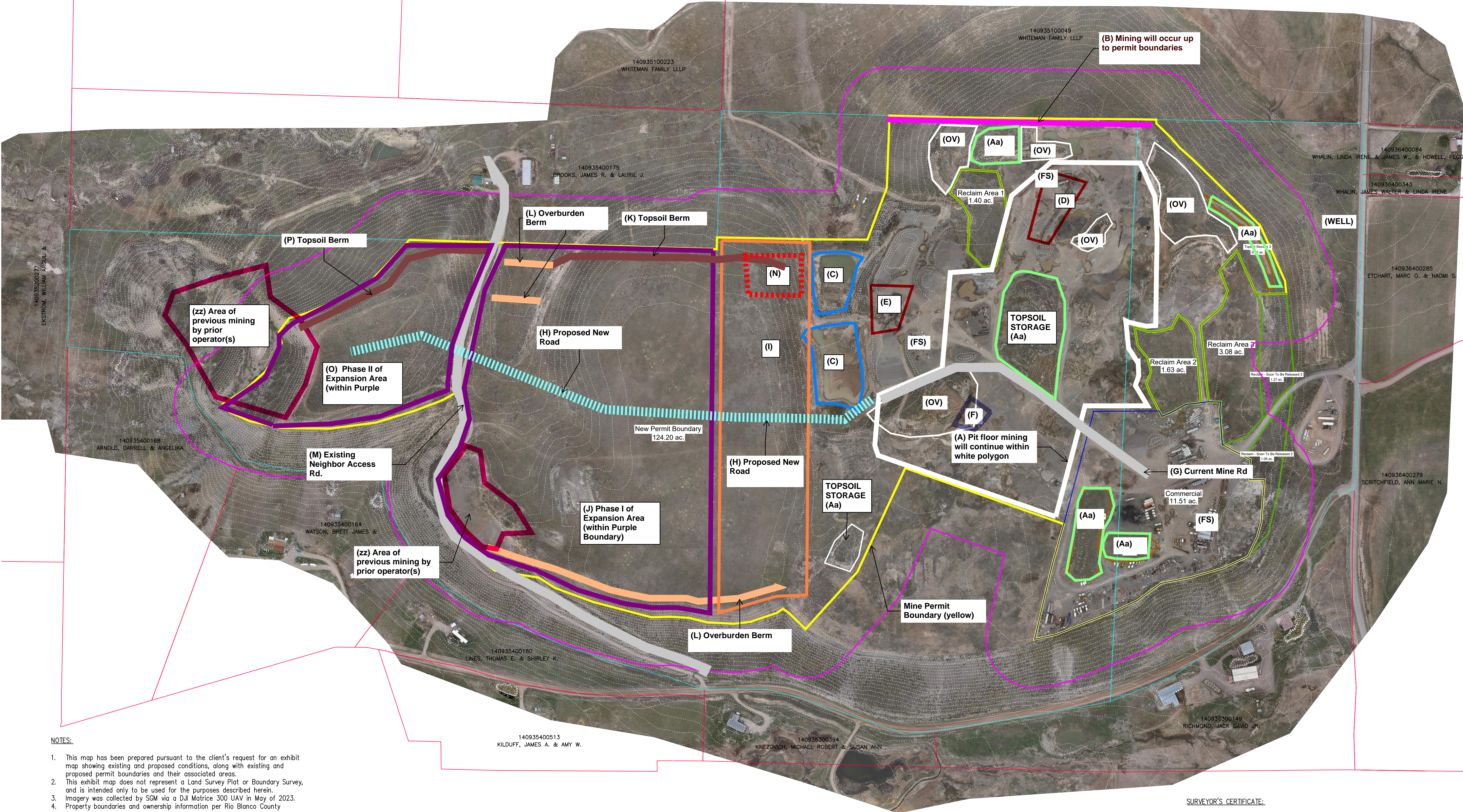

Mining Plan Map



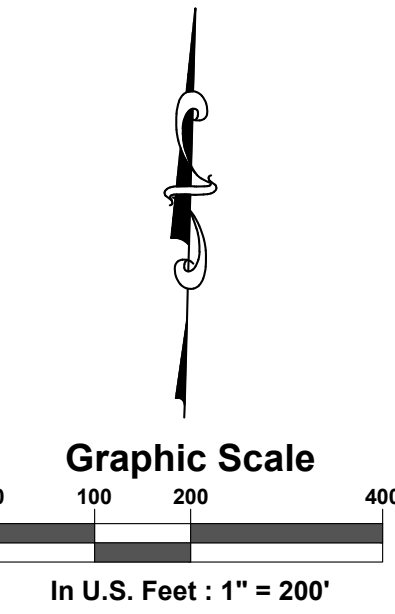

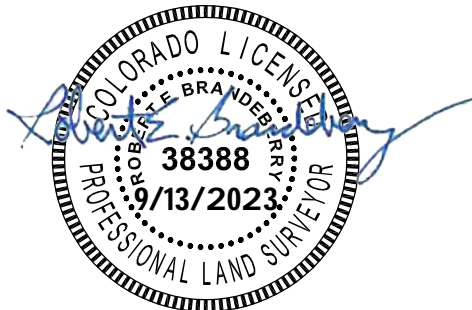
