4. THERE SHALL BE A MINIMUM 100' MINING SETBACK ON ONE SIDE OF THE MINING SETBACK AND A MINIMUM 20' SETBACK ON THE REMAINING SIDE.
5. THERE SHALL BE A MINIMUM MINING SETBACK OF 30 FEET FROM GAS LINES.
6. THE MINERAL RIGHTS OWNERS AND LESSEES SHALL HAVE 24 HOUR ACCESS TO THEIR OIL AND GAS FACILITIES.
