RE: Holcim Quincy Pit, Permit; M2000080 TR3 Adequacy #4

DRMS received the mine plan update for the Quincy Pit on 18 October 2023. The preliminary adequacy was sent to Holcim on 26 October 2023 and responses were received from Holcim on 27 October 2023. A second adequacy was sent to Holcim WCR, Inc on 15 November with DRMS receiving the response on 15 November. This letter constitutes the fourth adequacy round following our 5 December phone conversation clarifying acreages requested as per Exhibit D, the Mine Plan.

The current permit allows for:

- Disturbance:
- 36 acres at any one time comprising
 - 12 acres of prestripping
 - 12 acres mining and leveling
 - 12 acres in reclamation

DRMS understands from the phone conversation and the proposed mine plan Exhibit D that: stripping will increase from 12 to 16 acres active mining and grading will constitute approximately 60 acres.

Increasing the acres disturbed at any one time from the current permitted 36 acres to 76 acres.

Please submit a cost estimate (Exhibit L), for reclamation for the proposed 76 acres of disturbance. This cost estimate should include:
