The U.S. Department of Energy Office of Legacy Management (LM) is issuing this letter regarding the Gold Eagle Mining Inc. (GEMI) mines listed below that are leased to you by LM under the Uranium Leasing Program (ULP) lease agreements referenced above. These mines are permitted by the Colorado Division of Reclamation, Mining, and Safety (DRMS) and are on the following ULP lease tracts:

- C-SR-13, Burro Tunnel mine (DRMS ID: M1977-297)
- C-SR-13, New Ellison mine (DRMS ID: M1978-342)
- C-JD-5, JD-5 mine (DRMS ID: M1977-248)

LM submitted a letter to GEMI dated December 14, 2023, requesting revised reclamation plans and completed *Uranium Leasing Program Lessee Environmental Checklists* (LM-Form-4-20-22.0) for the above listed mines. LM acknowledges receipt of, and thanks GEMI for sending, revised reclamation plans on December 27, 2023, for the above listed mines. However, the checklists requested by LM have not yet been received as required under the terms of the lease agreements.

Starting in May 2021, LM has made numerous written requests to GEMI for the completed checklists related to these mines. To date, no completed checklists have been received by LM. Not submitting these checklists hinders the activities and plans to move forward with the reclamation and to meet GEMI's obligations under the lease agreements.

Please notify me via email within seven (7) calendar days of receipt of this letter indicating when LM will receive the completed *Uranium Leasing Program Lessee Environmental Checklists* for the above-listed mines.
