COMMENTS

This report documents the Division's observations taken during a partial inspection of the Roadside Portals Mine, Permit No. C-1981-041. The inspection was conducted on January 23, 2024 by Clayton Wein of the Division. Snowcap Coal Company (SCC) was represented during the inspection by Tonya Hammond. The weather was partly cloudy with a temperature of $49 \,^{\circ}$ F. The ground conditions were mostly dry with some damp areas.

REVEGETATION - Rule 4.15

Vegetative Cover; Timing:

The remaining disturbance at the Roadside Mine is approximately 0.4 acres (TR-69 Repair Area) located in the northern portion of what is referred to as Tract 71. The 0.4 acres were disturbed by the landowner in October of 2023. In November of 2023, SCC repaired the 0.4 acres by replacing the topsoil, roughening the surface, and reseeding the area. The straw waddles and disturbed boundary markers were also replaced. For more details, please refer to the Division's October 16, 2023 Inspection Report.

During the inspection, the TR-69 Repair Area was stable with no indications of erosional features (Photos 1 and 2). The recently repaired area has been exposed to snow and rain over the last couple of months. There was no indication of differential settling at the time of the inspection. The disturbed boundary markers and fence were intact and in good condition. A mine identification sign was observed posted on the southeast corner of the TR-69 Repair Area (Photo 3). The straw waddles were in good condition and no off-site impacts were observed (Photo 4).

During the inspection, the Landowner's northern trench on Tract 71 was observed to be dry. There was no evidence of recent water application in the trench. A portion of the trench is located adjacent to the northern portion of the TR-69 Repair Area. There were no indications of impacts to the repair area from the trench.


