Hello Joel,

We received a notice that corrective action was needed for three of our pits in Kiowa County that did not have the appropriate signage as per your message below;

*During my inspection, I noticed that there were some issues with the signage in front of each mine. I spoke to Allen about this and advised that the sign needs to state that "A reclamation permit for the operation has been issued by the Colorado Mined Land Reclamation Board (CMLRB)" in addition to the mine name, permit number, and permittee information that was already there. I have attached some example photos of signs that meet the criteria, which I've texted to Allen.*

*Currently, the deadline for corrective action is December 28, 2023. However, I understand that the holiday season can cause some delays in obtaining new signage. If you require an extension, please send me a written request. Once new signs have been put up, please email me images so I can verify that the issue has been resolved.*

We are sending you the pictures of the updated signs at the three pit locations that you referenced. We appreciate you giving us an extension to complete this as we have been significantly short staffed.

Please let us know if there is anything else we need to do in order to be in compliance.
