COMMENTS

This was a complete inspection of the Trapper Mine; permit C1981010, operated by Trapper Mining Inc. The inspection was conducted, and the report and photos prepared by me, Robin Reilley of the DRMS. Graham Roberts, Trapper Mine representative was present throughout the inspection. No hydrologic or air quality issues were detected at the time of inspection. Skies were cloudy and the air was calm with occasional snow flurries. Temperatures ranged between 25 and 35 degrees Fahrenheit. The site was snow covered.

o Fencing and delineation of the new permitted area at the west panel is outstanding (PR11).

INSPECTION

GENERAL MINE PLAN COMPLIANCE:

The inspection began in L Pit. The Molly Braun drag line was stationed at the south end of the pit. The drag line was idle as it was being worked on. The Baby Doe drag line positioned mid pit and was casting spoil. Two blasts were being prepared and drilled. Mining is complete at a lower section of L Pit and is ready for back filling.

Mining in N Pit was not occurring at the time of inspection. However, a blast was being set up at the west end to remove overburden for Q seam mining.

J Pit has been opened and no activity was occurring at the time of inspection. The Queen Ann dragline had excavated a large overburden pile.

I Pit is partially backfilled and topsoil has been placed in I Pit East. This area represents approximately 15 to 20 acres included in the proposed SL25 Phase I bond release that includes D Pit. Further I Pit mining to the south is anticipated. The preparation of a TR for this mining is underway.
