- 2.) Bearings shown on the accompanying Exhibit Map are Grid North.
- 3.) All existing site features were provided by Armstrong Consultants, Inc. The control for the aerial mapping is based on a "modified" state plane coordinate system.
- 4.) The basis of coordinates for this survey is the North America Datum of 1983-1992 (NAD 83 (1992)), based locally upon the NGS, PACs and SACs stations GNB A, GNB B, GNB C, and Z 360. The basis of elevations for this survey is the North America Vertical Datum of 1988 (NAVD 88), based locally upon the NGS station Z 360.
- 5.) Plane coordinates shown hereon are based on the Colorado Coordinate System of 1983-1992, North Zone. All plane coordinates are expressed in the terms of U.S. Survey feet, (CRS 38-52-103(2)).
- 6.) Modified plane (GROUND) coordinates are based on the Colorado Coordinate System of 1983-1992, North Zone, as modified to a mean elevation of 8185 feet. The combined scale factor (SCALE and ELEVATION) used to modify the coordinates is 0.99957133. The origin of the modified system is based on the published state plane value at GNB B.
