Dear Mr. Bowles:

Please accept this letter as our request to extend the due dates for the items in the inspection report dated November 21, 2023:

1) CORRECTIVE ACTIONS: The operator shall submit a Technical Revision, with the required \$216 revision fee, to update and clarify the current approved mine plan to reflect existing and proposed activities by 2/20/2024.

RESPONSE: Martin Marietta would like to extend this date to 5/30/2024 to match Corrective Action #3 so these oil and gas pad removals can be shown on the same maps.

2) CORRECTIVE ACTIONS: Implement approved weed control plan and provide proof to the Division that this has been done by 2/20/2024 in accordance with the Noxious Weed Control Plan approved with the original permit application in 2009.

RESPONSE: This inspection was completed in November and the Russian Olive trees in several areas, particularly near Phase 1C and Phase 3, were already going dormant. We have been advised to cut and treat the stumps when they are actively growing and stump treatment will work more effectively. Martin Marietta would like to extend this due date to 5/30/2024.

Please accept this letter as our request to extend the due dates for the problem cited in a separate letter dated November 29, 2023.

 CORRECTIVE ACTIONS: The Operator shall submit revised Mining and Reclamation Plan maps and revised narrative Exhibits D and E and an updated Exhibit L which reflect the altered reclamation plan in a technical revision by 3/1/2024
