## **OBSERVATIONS**

This inspection was conducted in order to observe reclamation progress as part of the Division of Reclamation, Mining and Safety's (Division) normal monitoring program. A representative for the operator was not present. Photographs are included with this report in order to illustrate some of the conditions observed.

The Gray Pit #1 is located approximately eight miles east of Montrose and accessed from Hwy 347. The site is a 112c operation that includes a total of 25.63 permitted acres. The Division currently holds a financial warranty amount of \$71,257.00 for this site. The Division has reviewed the reclamation costs, in order to ensure the financial warranty reflects the actual current cost of fulfilling the requirements of the Reclamation Plan, and determined that the current financial warranty amount is sufficient.

Final grading of the pit slopes is nearly complete. Grading appears adequate and blends well with the surrounding topography. Slopes are to be revegetated. The pit floor will be graded to a level configuration and surfaced with gravel for hay and agriculture equipment storage.

No problems or violations were noted during this inspection.
