Dear Ms. Kawcak;

Thank you for the timely submission of the Williams Fork 2023 ARR. The Colorado Division of Reclamation, Mining and Safety has completed its review of the above referenced report. Please see the Division's findings below regarding the report's compliance with the following Rules.

- o Rule 2.04.13(1) – The 2020 ARR is dated 14 February, 2024 and the Division received an electronic copy of the report on that date.
  - a. The name and address of the permittee is on the report form.
  - b. For the reporting year zero acres of lands were placed in the Acres Disturbed Category comprising backfill/grading, long term facilities and active mining areas. Active mining is not occurring at the site, however reclamation activities are taking place as permitted.
  - c. For the reporting year, 0.4 acres were reported to have been backfilled or graded.
  - d. For the reporting year, 42.7 acres of affected lands were seeded in the 9 years and less category for a cumulative total of 112 acres.
  - e. For the reporting year, 26.0 acres of affected lands were subtracted from the 10 years and greater category of seeded acres for a cumulative total of 377.9 acres.
  - f. No bond releases were conducted in 2023.
  - g. The operator conducted weed control activities throughout the site as summarized in the annual report.
  - h. Total acres disturbed comprise 570.7. The sum of Backfilling and grading (497.4), active mining (0), and acres in facilities (73.4), equal total acres disturbed (570.7).
