Cripple Creek and Victor Gold Mining Company (CC&V) received the Division of Reclamation, Mining, and Safety's (DRMS) *Additional Information Required and Issuance of Corrective Action, Grassy Valley Groundwater and Surface Water Monitoring Report November 2023*; Permit No. M-1980-244. CC&V has reviewed the additional information required in the letter dated January 30, 2023 from DRMS and has prepared the following responses for each comment. The DRMS comment (in **bold**) and CC&V's corresponding response (in *italics*) is presented below.

 It was the understanding of the Division through multiple discussions, including discussion's regarding P2023-008, with the Operator the purpose for constructing an access road to the Point-of-Compliance (POC) well location for GVMW-26A and 26B was to allow for safe access for drilling equipment and serve for consistent long-term access for sampling the POC wells.

During the November 2023 sampling event the Operator did not collect samples from POC wells GVMW-26A and 26B with no explanation given in the cover sheet. The only comment provided was on the field sheets which stated "Road packed with snow inaccessible." The Division noted the weather condition at the time of completing the field form for each well was clear and warm.

It is the Division's expectation that the access road to GVMW-26A/B will be maintained in a manner to insure year round access so samples can be collected from the POC wells. Additionally, if locations that are to be sampled were not sampled, then a narrative should be provided clearly stating the reason.

GVMW-26A and 26B were not sampled during the November monitoring period as the wells were inaccessible due to a substantial amount of snow accumulation that created a significant safety hazard. Weather conditions noted on the field sheets are provided as an observation and may be relative. Temperatures on 11/5/2023 ranged from 27 to 50 degrees Fahrenheit and the access road to the GVMW-26 wells is on a north-facing slope. This allows the slope to retain snow, even in warmer conditions. In addition, the road to the GVMW-26 wells is an offsite road that can't be maintained by mine resources; however, CC&V is in the process of identifying a contractor to maintain the road for year-round access moving forward.

In the December 2023 monitoring report, CC&V included a summary table of the status of each well during the monitoring period. CC&V will expand this table in future reports to provide a narrative and detailed explanation for wells that were not sampled during a given monitoring period.
