INSPECTION TOPIC: Availability Of Records

PROBLEM/POSSIBLE VIOLATION: Problem: The Division was notified on September 15, 2023, that as of October 1, 2023, IHC Scott will become the Great Plains Division of WW Clyde. To date the permit remains in IHC Scott's name despite that no longer being a valid entity. This is cited as a problem pursuant to Rule 1.16(3). By Rule the Operator has 30 days to revise the performance warranty and financial warranty documents and complete the Succession of Operators forms.

CORRECTIVE ACTIONS: This site is a 111 permit and a Minerals Permit Transfer and Succession of Operators cannot be done. In this case IHC Scott either needs to provide documentation that they are still a valid company and that the financial warranty remains in place. OR WW Clyde may apply for a new 110c reclamation permit over the top of the current 111 permit. Once the new permit is issued, IHC Scott may request release/termination of the original 111 permit since then there will be no lapse in jurisdictional. Note that a permit must remain in place for the life of mine (through completion of reclamation) not just until excavation has concluded. The corrective action is to provide the Division in writing 1) Documentation validating ICH Scott and the current financial warranty OR 2) Submit a new 110c permit application. Corrective action documentation is due Monday April 8, 2024.

OBSERVATIONS

This is a records check inspection conducted by the Colorado Division of Reclamation, Mining and Safety's (Division). The Collett Property is a 111 permitted site that consists of 9.07 acres. This site is located approximately seventeen miles north of Rifle, CO on the east side of SH 13. Amy Yeldell of the Division conducted the inspection. The Division did not physically visit the site.

Availability Of Records:

The Division was notified on September 15, 2023, that as of October 1, 2023, IHC Scott will become the Great Plains Division of WW Clyde. To date the permit remains in IHC Scott's name despite that no longer being a valid entity. This is cited as a problem pursuant to Rule 1.16(3). By Rule the Operator has 30 days to revise the performance warranty and financial warranty documents and complete the Succession of Operators forms.

This site is a 111 permit and a Minerals Permit Transfer and Succession of Operators cannot be done. Since 111 permits are tied to a specific government contract and therefore are not transferable.

In this case IHC Scott either needs to provide documentation that they are still a valid company and that the financial warranty remains in place. OR WW Clyde may apply for a new 110c reclamation permit over the top of the current 111 permit. Once the new permit is issued, IHC Scott may request release/termination of the original 111 permit since then there will be no lapse in jurisdictional. Note that a permit must remain in place for the life of mine (through completion of reclamation) not just until excavation has concluded.

The corrective action is to provide the Division in writing 1) Documentation validating ICH Scott and the current financial warranty OR 2) Submit a new 110c permit application. Corrective action documentation is due Monday April 8, 2024.

Financial Warranty:

The Division currently requires a financial warranty amount of \$72,551 for this site. The bond was last recalculated with permit issuance in 2023.

Other:

Pursuant to Rule 1.15(3) The Annual Report for Special 111(1)(a) Operations shall include a statement as to the date the public road construction project has or will terminate. During a phone conversation with Andy Carpenter on March 6, 2024, it was indicated that the project has concluded. This information should be formally conveyed in the next annual report.
