The Colorado Division of Reclamation, Mining and Safety (the Division) has received the New Horizon 2 Mine's submittal of required items for a technical revision on January 30, 2024. The information provided allowed the revision to be deemed complete on January 31, 2024. The Division has completed reviewing the application submittal and has the following adequacy question:

1. A part of Technical Revision No. 108 (TR-108) requested to reduce the New Horizon Mine's permit boundary to reflect the approval of Bond Release SL-26. SL-26 was approved on January 10, 2024 and Phase III released 1.80 acres. With the submittal of TR-108, several Maps were included with the proposed revised pages to reflect the request in the reduction of the mine permit boundary. Maps 2.04.10 (Baseline Vegetation Map) and 2.04.11-1 (Baseline Wildlife Map) were included with the updated permit boundary. An updated version of Map 2.04.9-1 (Baseline Soils Map was not included with the application. Please provide the Division with an updated version of Map 2.04.9-1 that reflects the requested change in the Mine's permit boundary.
