OBSERVATIONS

This inspection was conducted as part of the Division of Reclamation, Mining and Safety's (Division) normal monitoring program. A representative for the operator was not present. Photographs are included with this report in order to illustrate conditions observed.

The Base Products Gravel Pit #2 is located approximately 3.25 miles northwest of Montrose and is accessed from Lasalle Road. The site is a 112c operation that includes a total of 73.8 permitted acres. The Division currently holds a financial warranty amount of \$193,346.00 for this site. The Division has reviewed the reclamation costs, in order to ensure the financial warranty reflects the actual current cost of fulfilling the requirements of the Reclamation Plan, and determined that the current financial warranty amount is sufficient.

Mining has not yet commenced at this site. The site is currently undisturbed by mining operations. The area is currently utilized as irrigated farm land.

No problems were noted.
