COMMENTS: The subject application is for an acreage release of 118.12 acres at the NCCI Pit #1 water storage cell since mining is complete and a clay liner was approved for the pit by the Division of Water Resources (DWR) on November 30, 2023. In addition, the subject application is requesting a surety (bond) reduction for the clay liner and the northern cell which was completed and backfilled. The pit is to be reclaimed as a water storage reservoir.

Lagged depletions which occur to the South Platte River from past water consumption associated with mining activities at this site are covered by the NCCI Pit #1 Substitute Water Supply Plan (SWSP), Plan ID 3670, approved for the period of January 1, 2024 through December 31, 2024. This 2024 SWSP covers lagged depletions from past mining activities which affect the stream during 2024. The attached table shows the lagged depletions in 2024, 2025, and 2026 based on modeling provided by the Applicant and the replacement water from the City of Thornton. The lagged depletions exceed the replacement water provided by the City of Thornton as approved in the 2024 SWSP. This office does not recommend approval of the Applicant's request for acreage release and bond reduction until they have obtained an SWSP to replace all lagged remaining depletions which will occur in 2025 and 2026.

Water shall not be impounded in the reservoir except pursuant to lawful diversions allowed by statute or decree. At all other times, all inflow of water into the reservoir from any source, including precipitation and groundwater inflows, shall be removed by the Applicant.
