Structures within 200 ft of Affected Lands Boundary

1 STRUCTURES

A list of owners of property within 200 feet of the affected lands boundary is provided herein. Cripple Creek and Victor Gold Mining Company (CC&V) previously provided a geotechnical engineering evaluation to demonstrate that permanent manmade structures within 200 feet of the affected lands boundary and within the affected lands boundary would not be impacted by CC&V activities. A report was developed by Lewicki and Associates titled *Exhibit T Permanent Manmade Structures*, January 2017, which assesses the stability of the permanent structures based on information provided in the engineering evaluation of slope stability for the mine areas by Call & Nicolas Inc (CNI). The Lewicki and Associates report, which includes the CNI engineering evaluation, is provided in Appendix 9. This report concluded that none of the structures within 200 feet of the affected lands boundary would be impacted by CC&V operations. The conclusions drawn by the 2017 evaluation have not changed by Amendment 14 activities, because there are no new structures located in the vicinity of VLF1 Phase 6 and VLF2 Phase 4 construction.

Section 5 of the VLF Expansion Detailed Design report, provided in Appendix 1, presents the stability analyses performed for the proposed Phase 4 and Phase 6 configuration. The stability analysis concludes the design adequately addresses and mitigates the potential for slope failure, in accordance with DRMS requirements and guidelines.

As of the submission of this application, CC&V has not identified any new structures within 200 feet of the area that is affected by the changes under this Amendment 14. The current list of structures and their owners within 200 feet of the affected lands boundary is the same as it was for the Amendment 11 and 13 applications. The list of current structures and owners is provided with the Lewicki and Associates report in Appendix 9. Structure agreements were mailed to owners of structures within 200 feet and utilities as part of the Amendment 14 application.
