All final reclamation, including backfilling, grading, topsoil import and spreading, and seeding, was completed in May of 2023. All drill holes were also plugged and reclaimed according to the Abandonment Report submitted in May of 2023. A Final Release Request was submitted at that time and a DRMS inspection followed. DRMS then issued a letter confirming the final work but also stating that more vegetation was needed and the bond release request should be resubmitted when the vegetation is adequate. We are now evaluating that vegetation. The current bond is \$5800.
