On May 13, 2024 the Division of Reclamation, Mining and Safety (Division) filed your Technical Revision request (TR-24) for the Pikeview Quarry, Permit No. M-1977-211. During review of the material submitted, the Division determined that the following issue(s) of concern need to be adequately addressed before the Technical Revision can be considered for approval. Please provide the following:

1. Please provide an updated list of species added to the seed mix and or shrub and tree list for the site if new species have been added to the site.
2. The design plans for TR-24 have been reviewed by the Division's surface water specialist, Rob Zuber. His comments are attached below. Responses to these items should be included with the responses to the above adequacy item.

Please submit your response(s) to the above listed issue(s) by **June 7, 2024**, in order to allow the Division sufficient time for review. If you cannot address the above issues by **June 7, 2024**, please request an extension to the decision due date in order to ensure adequate time for the Division to review the materials. A decision due date of June 12, 2024 has been set. If any adequacy issues remain by the decision due date the Division may deny your request.

The Division will continue to review your Technical Revision and will contact you if additional information is needed.

Review of Revisions to Surface Water Channels

I reviewed the TR-24 application submitted for Pikeview Quarry. I found no problems with the general design or the hydrology and hydraulics calculations. However, I do have the following small adequacy items.

1. On Sheet 300-001 (Channel Plan), there is a label "Tie into Existing Drainage," but it appears that the leader associated with this label points to the wrong location. This drawing needs to be revised.
2. The title for Sheet 300-006 is "Transition Zone North Channel." However, this sheet also includes figures for the South Channel (namely, the Plunge Pool). The title should be revised to include both channels.
