Mr. Dye,

All approved permit documents associated with the Colowyo Mine (C-1981-019), including hydrology maps, can be found on the Division's public interface Laserfische located on the Division's website https://drms.colorado.gov/data. The following link is to the Laserfische user-guide on how to navigate permits and associated public documents within Laserfische. This document is provided in the DRMS website link I included earlier as well.

It is often helpful to filter through the documents using the DRMS Permit Index template and using the IBM Index Class Name dropdown of "Permit File". These instructions can also be found within the referenced user-guide. This will further filter to all documents associated with the Colowyo Mine permit which will include the information that you have inquired about.
