They spread it in an unauthorized road on the Golden Age claim. The dump leaked toxic chemicals into the water table violating env. law in addition to the criminal thievery in violation of law. This activity was never documented by Michael Cunningham, Patrick Lennberg, or Jared Ebert, and was never prosecuted appropriately by law enforcement.
