On June 4, 2024, the Division of Reclamation, Mining and Safety (Division/DRMS) received the monthly groundwater elevation data submitted by J&T Consulting for the Derr Pit.

Per Technical Revision 5, the Operator is required to sample on-site monitoring wells and off-site, privately owned, domestic and irrigation wells, and submit the report to the Division monthly. If the trigger point of 2 feet of difference for two consecutive months is reached at any of the off-site wells, the Operator will submit a report and mitigation plan to the affected owners and DRMS.

The Division reviewed and accepts the groundwater data and dewatering volumes submitted for May 2024.
