Attached is the stormwater discharge permit. It expired in 2021, we submitted a timely renewal that hasn't been acted on yet.

There are three things we are doing to address this pond issue:

- 1. Obtain a SWSP we'll start that process tomorrow
- 2. Dewater we would start dewatering tomorrow but CDPHE hasn't acted on our application from three years ago requesting dewatering be added to the discharge permit. We are submitting a modification request to get formal approval to dewater but that will take a few months. Once we get it, we will dewater
- 3. We are going to start backfilling the pit to reduce the exposed area.

Note that water levels increased after rain events, so I believe most of the water is surface water rather than groundwater.

I am open Tuesday May 21 and Friday May 24, no answer back yet from Martina our plant manager. I should be able to confirm her attendance in the morning.

Hi Joel.

As a follow-up on our conversation regarding the groundwater levels in the Bennett Pit, will you send me a copy of the discharge permit from CDPHE for the permit file?

For reference, I attached the comment letter from DWR submitted for the last amendment. It confirms that you planned to evaluate the site to determine if mining below the water table is feasible and could submit a technical revision to proposed lining the area. I know you are trying to decide on the next steps. In the meantime, as you already know, you will need to

pump out the water that is in the pit, and also apply for a SWSP to replace the evaporation losses. We can discuss this more during the inspection next month.

The Water Quality Control Division received an application from Albert Frei and Sons Inc renewal on 7/2/2021. The application requests discharge authorization for AFS Bennett Pit aka Bennett Sand and Gravel Pit 2 located at 50000 E 72 Ave Bennett Facility SIC 1442.

The application has been reviewed and is considered complete for the purposes of filing. The Division has not verified all of the information contained in your application and has relied upon your signed certification to determine that the information is true, accurate, and complete. No renewal permit has been issued at this time.

In the event that the Division does not issue a renewal permit in advance of the permit expiration date of 12/31/2021, the expired permit shall be administratively extended and continue in force to the effective date of the new permit.
