This is simply a person or company that files the appropriate paperwork for an entity, but has no other official role and definitely does not authorize for such things as this. I've had other inspectors with the same original information and I believe I was told you were trained this way, but you can see in the link provided that the information is incorrect and the role is just administrative.
