That consisted of opening up an old previously reclaimed drill road and establishing several new cross-country routes, then pad construction where authorized. Lastly, after drilling, the drill hole was plugged and abandoned as per the permit, the site recontoured and seeded and bedded with an approved mix and in a approved manner
