During 2023, the only work on the project was that authorized by the NOI. That consisted of opening up an old previously reclaimed drill roads and pad construction where authorized. Lastly, after drilling, the drill hole was plugged and abandoned as per the permit, the site recontoured and seeded and bedded with an approved mix and manner.

Due to the possibility of more drilling in the area in 2024, approximately 1,130 ft (0.3 acre) of historic existing access roads were left unreclaimed. These access roads were stabilized by the aggressive use of rolling dips (water bars), straw wattles at the outlet of the dips, and seeding.
