On July 31, 2024 the Division of Reclamation, Mining and Safety (Division) received your past due 2023 Annual Report, Map, and fee payment. Therefore, the Notice of Violation for C.R.S. 34-32.5-116(3)(a) and (b) sent out on June 26, 2024 has been withdrawn from the scheduled August 21-22, 2024 meeting of the Mined Land Reclamation Board, and you are no longer required to attend this meeting.
