Dear Ms. Ridley,

Tri-State Generation and Transmission Association Inc. (Tri-State), is the parent company to Axial Basin Coal Company, which is the general partner to Colowyo Coal Company L.P. (Colowyo). Therefore, Tri-State on behalf of Colowyo is submitting minor revision 258 (MR-258) to Permit No. C-1981-019.

MR-258 proposes to brush a pre-existing two-track road as Colowyo needs to access the 69 kV power line and power poles on the west side of Taylor Creek. This light use road was originally permitted for disturbance under MR-255, and as Colowyo commenced brushing it was determined the disturbance area permitted under MR-255 was not correct, and MR-258 provides the corrected alignment and disturbance area. It is requested that the Division calculate the change in reclamation liability with the disturbance proposed under MR-258.
