On July 17, 2024, the Division of Reclamation, Mining and Safety (Division) issued a Reason to Believe a Violation Exists and Notice of Board Hearing scheduling an enforcement hearing before Mined Land Reclamation Board (Board/MLRB) during the September 18-19, 2024 Board meeting. As the Division and CC&V initiated discussions regarding a possible stipulated agreement for the violations, the formal Board hearing was rescheduled to the October Board meeting. As these discussions continue, the formal Board hearing has now been rescheduled to the **December 11-12**, **2024** Board meeting. The hearing will now be held at 1313 Sherman Street, Room 318, Denver, Colorado, beginning at 9:00 a.m. on December 11<sup>th</sup>, or as soon thereafter as the matter can be considered. In order to be considered at the hearing, all exhibits, materials and witness testimony you wish for the Board to consider must be submitted by 12:00 PM on December 2, 2024, via email to the MLRB Administrator, Camille Mojar at: <a href="mailto:Dnr drms mlrb-submittals@state.co.us">Dnr drms mlrb-submittals@state.co.us</a>.

If you have good cause not to appear in person you must submit a request to the MLRB to appear virtually (via ZOOM). To do so, please submit an email to the MLRB Administrator, no later than 5:00 PM on December 6, 2024, for Board consideration. If approved, you will receive an authorization code to attend the meeting for this matter. **Please note that only Parties and those who will be testifying may participate in the hearing**.
