We have made changes to the map, the high wall height, and the acreage. Please see attached map and letter for details.

As defined by the Minerals Rules, a Technical Revision (TR) is: "a change in the permit or application which does not have more than a minor effect upon the approved or proposed Reclamation or Environmental Protection Plan." The Division is charged with determining if the revision as submitted meets this definition. If the Division determines that the proposed revision is beyond the scope of a TR, the Division may require the submittal of a permit amendment to make the required or desired changes to the permit.

The request for a TR is not considered "filed for review" until the appropriate fee is received by the Division (as listed below by permit type). Please submit the appropriate fee with your request to expedite the review process. After the TR is submitted with the appropriate fee, the Division will determine if it is approvable within 30 days. If the Division requires additional information to approve a TR, you will be notified of specific deficiencies that will need to be addressed. If at the end of the 30 day review period there are still outstanding deficiencies, the Division must deny the TR unless the permittee requests additional time, in writing, to provide the required information.

There is no pre-defined format for the submittal of a TR; however, it is up to the permittee to provide sufficient information to the Division to approve the TR request, including updated mining and reclamation plan maps that accurately depict the changes proposed in the requested TR.

CHANGES TO MAP FOR TECHNICAL REVISION

- 1. Removed Phases**
- 2. Entrance to pit relocated and corrected on map**
- 3. Move County Road 611.1 to the south 30' (see Map Legend and permission letter from Huerfano County)**
- 4. Upon reclamation, County Road 611.1 will be put back to original placement ***
- 5. Direction of mining changed to West to East (See Map Legend)**

***When permit with Huerfano County comes due in 2026, they may eliminate or give permission to mine through county road 611.1**

Topsoil is placed along the disturbance boundary and outside of the pit boundaries, out of the ongoing mining, usually long piled to accept moisture for vegetation.

OTHER CHANGES MADE FOR TECHNICAL REVISION

- 1. High wall length increased to 1500'**
- 2. Maximum disturbance increased to 36 Acres with 10 Acres possibly reclaimed and seeded and may need to be re-seeded at any given time.**
