OBSERVATIONS

This inspection was conducted as part of the normal monitoring program established by the Colorado Division of Reclamation Mining and Safety's Active Mines Program. The Bulldog Project is listed as an active Notice of Intent to Conduct Prospecting Operations (NOI) located approximately 3.5 miles northwest of Creede, CO in Mineral County at an elevation of approximately 11,000 feet. Randy McClure, a representative of Rio Grande Silver, Inc. accompanied the inspection. The Division holds a \$14,727.00 Financial Warranty for the site. A reclamation cost estimate was not performed as a result of this inspection.

The NOI consists of 4 pads, AC1, AC2, BD-7 and BD-8. AC1 and AC2 have not yet been constructed and are located in the Rat Creek Drainage. The BD-7 and BD-8 pads have been constructed. There is an access road that extends from the San Juan Silver Project NOI and connects BD-7 and BD-8. There was no activity at the site at the time of the inspection. The exploration holes that were drilled during the exploration campaign have been plugged and abandoned and the mud pit to collect cuttings was covered. Abandonment reports were submitted to the Division. The only equipment that remains onsite are an empty water tank and mud mat. The pad appears stable with no visible signs of erosion or slumping. The roadways are in good condition but would need to have down trees that fell over the summer removed to bring equipment to site. No state listed invasive species were identified in the reclaimed area.

No problems or violations were noted or observed during the September 25, 2024 inspection.
