The Colowyo Mine is located approximately 28 miles south of Craig, Colorado.

Colowyo currently holds a surety bond in the amount of \$119,000,000.00. With this application, Colowyo will be requesting relinquishment of 60% of the bond held for the Phase I, and 25% of the bond held for the Phase II, and 100% of the bond held for the Phase III as applied for under the application.
