The Colorado Division of Reclamation, Mining and Safety (the Division) has received and reviewed the 3<sup>rd</sup> Quarter 2024 Pond Inspection Report for the McClane Canyon Mine. The report was received on October 24, 2024. The Division has the following comments:

**3<sup>rd</sup> Quarter Pond Inspection Report**

4.05.9(17) – All Impoundments are inspected quarterly, by a qualified person designated by the operator, for the appearance of structural weakness and other hazardous conditions. The reports are retained at the Mesa County Recorder's office in Grand Junction, CO, and copies of the reports are submitted to the Division on a quarterly basis.

The inspection of the pond was conducted by Chuck Silengo on September 19, 2024. The report indicates that there were no issues. The field inspections by the Division reflect the information in the report.
