The Division has received and reviewed the quarter three Sediment Pond Report, for the Peabody Sage Creek Mine. The Sediment Pond Report was received electronically by the Division on 31 October 2024. Thank you for your timely submittal of this information. Peabody Sage Creek Mine submits Sediment Pond Report to the Division, in accordance with Rule 4.05.9(17). The inspection took place over several days in September 2024 and was conducted by Miranda Kawcak.

Peabody Sage Creek Mine reported the following Pond/outfalls discharged in September.

- Pond 2 NPDES 002
- Pond 3 NPDES 003
- Final Pit Impoundment
- Lower Sump, diked pond
- Upper Sump, diked pond
- Portal Sump #1 upper north
- Portal Sump #2 lower south

Pond banks were in good repair and trash racks were clear at the time of inspection. The Pond 2 flume requires resetting and rodent burrows around the site need ongoing maintenance. The Professional Engineer Certification was included in the submittal.
