Dear Mr. Porco,

On November 5, 2024, the Colorado Division of Reclamation, Mining, and Safety (the "Division") issued a notice of violation (NOV no. MV-2024-022) for failure to submit the required annual report, map, and fee in accordance with C.R.S. § 34-32.5-116(3)(a) and (b). On November 13, 2024, the Division received the required annual report, map, and fee. Therefore, the Division has withdrawn this matter from consideration by the Mined Land Reclamation Board (MLRB) and a hearing will not be held during the December 11-12, 2024 MLRB meeting regarding this issue.

The civil penalty assessed for MV-2024-022 is \$323. This civil penalty is due and payable by **December 19, 2024**. Failure to timely submit any due and unpaid civil penalties shall result in the immediate submittal of those penalties to State collections.
