Re: Seeley Reservoir Stockpiles, File No. M-2023-043 Receipt of 112c Construction Materials Reclamation Permit Application Package, Incompleteness Notice No. 1

Dear Scott Cockroft:

On November 15, 2024, the Division of Reclamation, Mining and Safety received your 112c Construction Materials Reclamation Permit Application package for the Seeley Reservoir Stockpiles, File No. M-2023-043. Preliminary review of the information received determined that <u>the following additional information must be received</u> before the Division can consider your application as being submitted and technical review can begin:

Application Form

- 1. <u>On the first page of the application:</u>
 - (i). Item #1 asks for the "Applicant/operator or company name (name to be used on permit)". The Applicant/Operator is listed as "Four C Sons, Inc" without a period after 'Inc'. The organization name must match how it is listed on the Colorado Secretary of State website, exactly.
 - * Please update item #1 on the application form to read "Four C Sons, Inc." as it is listed on the Secretary of State website, and re-submit the page.
- 2. <u>On the second page of the application:</u>
 - (i). Item #9, under "Location Information" the information given for Quarter Section and Quarter/Quarter Section is incorrect. The Applicant states that the Quarter Section is SW and the Quarter/Quarter Section is SE. The Division believes this should instead read as the Quarter Section is SE and the Quarter/Quarter Section is SW (see screenshot below).





- * Please correct the information for the quarter section and quarter/quarter section and re-submit the page.
- 3. <u>On the third page of the application:</u>
 - (i). Item #11, under the Applicant/Operator information and under the Inspection Contact information, the "Company Name" is listed as "Four C Sons, Inc" – without a period after 'Inc'.
 - * Please update item #11 on the application form to read "Four C Sons, Inc." as it is listed on the Secretary of State website, and re-submit the page.
- 4. <u>On page eight of the application:</u>
 - (i). The Applicant/Operator is listed as "Four C Sons Inc." without the comma, in two places on the form. On the Secretary of State website the Company/Applicant name is listed as "Four C Sons, Inc.". It is important that the Applicant's name matches exactly with the spelling depicted on the Secretary of State's website.
 - * Please correct the spelling to read "Four C Sons, Inc.", re-notarize, and resubmit the page.

Your application will not be considered submitted until all the information listed above is received and found sufficient to begin our review.

You have sixty (60) days from the above date (until **January 24, 2025**) to submit all necessary documents that the Office needs for an application to be considered filed. If, at the end of the

sixty day period, the application has not been determined to be filed with the Office, the Office may deny the application and terminate the application file.

This letter shall not be construed to mean that there are no other technical deficiencies in your application. The Division will review your application to determine whether it is adequate to meet the requirements of the Act after submittal of all required items.
