Entire Permit Area (bright green boundary)

See Map 2 for expanded view of actual affected area.

Note: Access Road (magenta in permit boundary, dark red outside permit area) is a permanent, post-mining road as approved by La Plata County. Area cleared on mesa top was chained by landowner before mining or access construction began.

CR-213 (La Posta Road) shown on right edge of this map, connecting to SH-550 at Bondad Junction approximately 2000 feet to the south-southeast.

Mining activities are presently intermittent but only until the County allows haul of materials from the operation, as the pit is not officially in full operation.

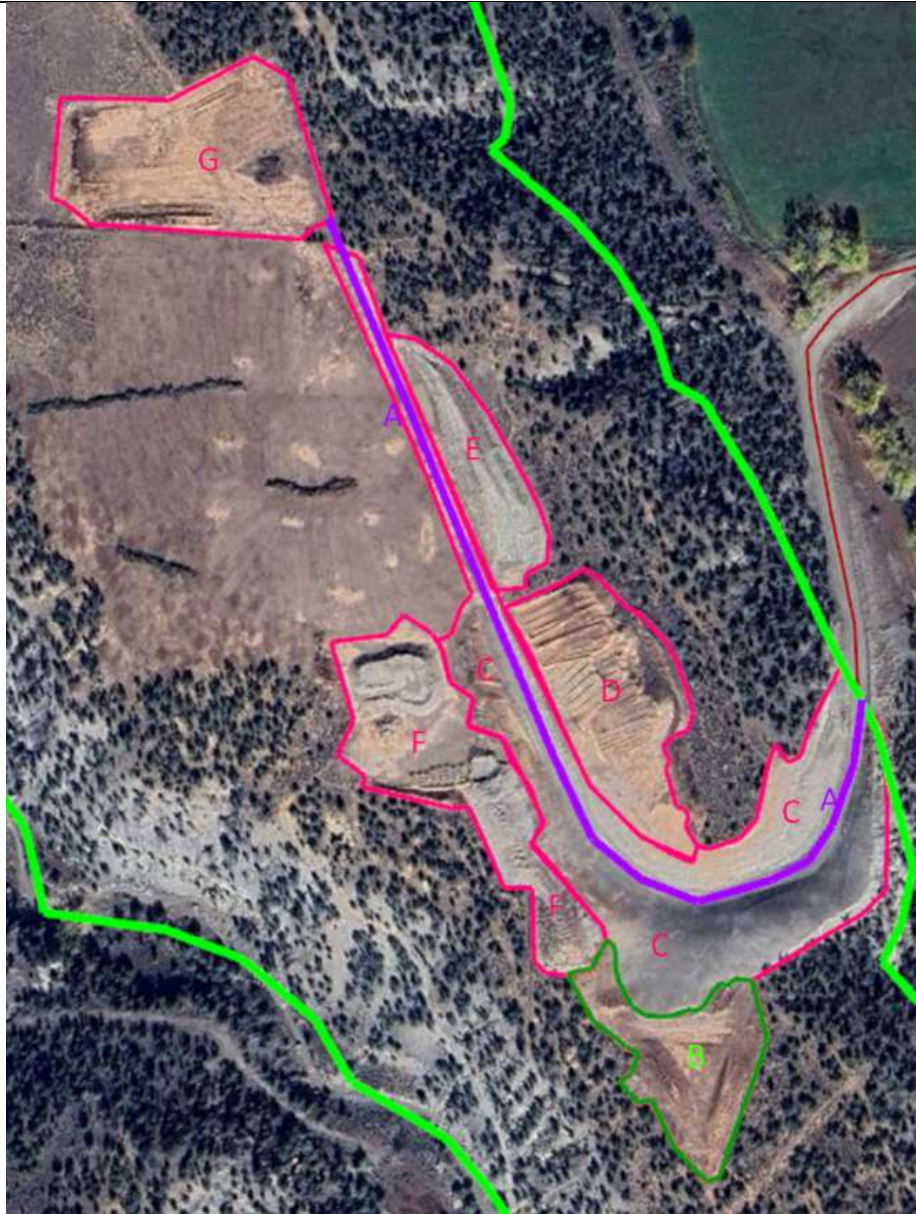
Currently Affected Area (bright green is permit boundary). See Map 2 for expanded view of actual affected area.

Access road on permit boundary (0.41 miles long) is approximately 30 feet wide including shoulders and is a permanent, post-mining feature. Areas of roadcut inside permit boundaries are to have soil replaced and seeded once road is finalized, but is currently at final, post-mining grade.

No expansion of affected areas is proposed in 2025.

All areas protected by storm water best management practices. There is no potential for surface discharge of water from affected areas, per NPDES stormwater permit. There will be no discharge of process water, and no exposure of ground water.

There is presently no equipment permanently located and operating at the location.
