On March 12, 2024 a Multi Person Inspection took place at the Eagle-Gypsum Mine (Mine ID #: M-1984-041) with Amy Yeldell and Leigh Simmons. An inspection report was issued on March 25, 2024, and a corrective action was identified for the operator to submit a Technical Revision to clarify the current approved Mining and Reclamation Plans. The Technical Revision was filed on June 24, 2024, in which there was a review of the material resulting in four (4) Adequacy Reviews in order to address concerns in the Technical Revision. A response was submitted to DRMS on December 6, 2024. On 12/18/2024, a fifth Adequacy Review was requested due to questions regarding the four previous Adequacy Reviews.

American Gypsum requests to extend the adequacy review response due date to January 10, 2024.

American Gypsum has hired a consultant to assist with preparation of the Adequacy Review responses. Information and data will be collected at the mine site, which will provide adequate support to address the concerns in the Technical Revision. The consultant believes they will be able to meet the extended deadline of 01/10/2024.
