Dear Mr. Lennberg:

I am writing on behalf of Coulson Excavating Company, Inc. ("Coulson") following Coulson's meeting with you and Senior Environmental Protection Specialist Jared Ebert on December 16, 2024. Kaplan Kirsch LLP ("Kaplan Kirsch") is assisting Coulson in responding to the August 14, 2024 Preliminary Adequacy Review letter (the "Letter") provided by the Division of Reclamation, Mining and Safety ("DRMS"). As discussed at the meeting, we intend to provide a response to this Letter shortly; however, we understand from you that additional review by DRMS may be required prior to a Board hearing on the matter. Accordingly, and at your suggestion, we are requesting an extension of the decision date referenced in the Letter to March 4, 2025. Coulson previously requested an extension of the matter until January 10, 2025.

This is in keeping with Rule 1.4.1(9) of the Mineral Rules and Regulations of the Colorado Mined Land Reclamation Board, which provides that "[a]t the request of the Applicant, the review time may be extended and the decision date reset, not to exceed three hundred and sixty-five (365) days from the date the application was filed. The additional time may be requested to allow the Applicant an opportunity to provide information necessary to meet the adequacy requirements of the Office." The Letter states that the application was deemed complete for purposes of filing on June 14, 2024.
