On December 21st, 2024, the Colorado Division of Reclamation, Mining and Safety ("DRMS" or "Division") received your request for an extension of the application decision date for the Notice of Intent to Conduct Prospecting Operations for Hard Rock/Metal Mines ("NOI"). The Division hereby approves an extension of the application decision date. The new application decision due date is **January 20**, **2025**.

Pursuant to Rule 5.1.3(c) of the Hard Rock/Metal Mining Rules and Regulations, all adequacy items must be addressed by January 20, 2025. If this date arrives and the adequacy concerns have not been addressed and/or the additional financial warranty has not been submitted and accepted by the Division, the NOI will be denied. Please note that prospecting operations may not begin until authorized by the Division and until the Plan of Operations has been approved by the Bureau of Land Management.
